

# Privacy Policy

However, limited information may still be processed in the following ways:

### a) Information you voluntarily provide

- name or alias
- email address
- Discord username
- any information you include in your message

### b) Technical information processed automatically

Like most websites, certain technical data may be processed automatically by our hosting and infrastructure providers when you visit the Website. This may include:

- IP address
- browser type and version

- device type
- pages requested
- date and time of access
- basic request, error, and security logs

This information is used only for security, reliability, abuse prevention, and technical maintenance.

### **3. No Cookies / No Tracking**

We do not currently use:

- analytics cookies
- advertising cookies
- tracking pixels
- Google Analytics
- Google Tag Manager
- behavioral profiling tools

If this changes in the future, this Privacy Policy will be updated accordingly.

### **4. How We Use Information**

We use personal data only where reasonably necessary to:

- respond to emails or inquiries
- provide access to community-related channels or information
- manage Discord invite or community access where applicable
- maintain website security and performance
- prevent abuse, spam, fraud, or unauthorized activity
- comply with legal obligations

We do not sell personal data.

### **5. Legal Basis for Processing**

Where applicable under privacy laws such as the GDPR, we rely on one or more of the following legal bases:

- your consent (for example, when you contact us by email)
- our legitimate interests (such as operating the Website, maintaining security, and managing community access)
- compliance with legal obligations

## 6. Third-Party Services

We may rely on third-party services to operate the Website and related community access. These services may process limited personal data as necessary for their functions.

These may include:

- Vercel (website hosting and delivery)
- Discord (community access and communications)
- email providers (if you contact us via email)

These providers operate under their own privacy policies and terms.

## 7. Data Retention

We retain personal data only for as long as reasonably necessary for the purpose for which it was collected, including:

- responding to communications
- managing community access
- maintaining security records
- complying with legal or operational requirements

## 8. International Data Transfers

Because our service providers may operate internationally, your information may be processed or stored outside your country of residence.

Where required, reasonable safeguards are used to support such transfers.
